Voluntary Waiver and Indemnification Form

THIS VOLUNTARY WAIVER AND INDEMNIFICATION FORM MUST BE ACKNOWLEDGED, REVIEWED AND SIGNED BY ALL PLAYERS AND MUST ACCOMPANY THE TOURNAMENT REGISTRATION FORM IN ORDER TO PLAY

VOLUNTARY WAIVER, RELEASE AND ACKNOWLEDGEMENT OF RISK. In consideration of being permitted to participate in the BiBo! "Ultimate 4V4 Soccer" Tournament (the "Event") conducted by Bibo Soccer LLC ("HOST"), the undersigned, and his/her parent or guardian (if the player is under 18 years of age), for themselves, their personal representatives, heirs and next of kin, hereby release, waive and discharge, and covenant not to sue HOST, all Event sponsors, all Event affiliates (including any and all clubs and associations), the owner of the Event premises, volunteers, and charities, and each of their principals, agents, directors, officers, employees, attorneys, insurers, servants, parents, divisions, subsidiaries, predecessors, successors and representatives (collectively referred to herein as "Event Organizers") from any and all liability to the undersigned, their wards, personal representatives, assigns, heirs and next of kin for any and all injury, loss or damage, and any claims and demands of every kind and nature, for damage actual and consequential, past, present and future, arising out of or in any way related to the Event, including but not limited to any claims of personal injury or death from participation in the Event and the loss of property by theft or otherwise during the Event, any publicity relating to the Event, any prizes awarded, and any loss of collegiate or high school eligibility as a result of participation in the Event, whether caused by the negligence of the Event Organizers or by any other cause.

INDEMNIFY AND HOLD HARMLESS. The undersigned (and his/her parent or guardian) hereby agree to indemnify and hold harmless Event Organizers and each of them from loss, liability, damage or cost they may incur due to participation in the Event, whether caused by the negligence of the Event Organizers or by any other cause.

ACKNOWLEDGEMENT AND ASSUMPTION OF RISK. The undersigned and his/her parent or guardian hereby acknowledge, agree and represent that participation in the

Event involves risk of injury or harm from physical, emotional and mental stress and violence which they voluntarily and willingly accept and undertake; and further warrant that they, have or will inspect the facilities, premises, and equipment to be used in the Event, and immediately notify and inform Event officials of any unsafe conditions, and will refuse to participate until such conditions are corrected to their complete satisfaction; and further assume full responsibility for all risk of bodily injury, death, emotional injury and property damage in any way caused by or related to the Event including that which may be caused by negligence of the Event Organizers or otherwise.

PUBLICITY. The undersigned (and his/her parent or guardian) hereby consent to the use without compensation, of his/her name and/or likeness, biographical material and/or voice in publicity and advertising concerning the Event, any Event sponsors and/or their promotion in any and all media and throughout the world.

ELIGIBILITY. Before registering all participants should contact their coach or athletic director and determine how eligibility may be affected, if at all, by registering for the Event.

GOVERNING LAW. The undersigned agree that this Voluntary Waiver and Release of Liability and Indemnification and Hold Harmless Agreement shall be governed by the Commonwealth of Colorado law and that the Colorado courts located in Denver County, Colorado shall have exclusive jurisdiction of any action arising from the Event or this agreement. The undersigned and his/her parent or guardian, if applicable acknowledge that they have read the above, understand it, and are executing this document voluntarily.
